ZUORA COMMUNITY TERMS OF USE

THESE ZUORA COMMUNITY TERMS OF USE ("TERMS OF USE") ARE ENTERED INTO BY AND BETWEEN ZUORA, INC. ("ZUORA") AND YOU, OR THE INDIVIDUAL, THE COMPANY, OR THE LEGAL ENTITY YOU REPRESENT ("YOU"). THESE TERMS OF USE WILL BE LEGALLY BINDING WHEN YOU CLICK THE "I AGREE" BUTTON BELOW. CAREFULLY READ THIS AGREEMENT BEFORE CLICKING "I AGREE."

YOU REPRESENT THAT YOU HAVE AUTHORITY TO ENTER INTO THIS AGREEMENT ON BEHALF OF YOUR COMPANY (OR OTHER LEGAL ENTITY). Zuora will not take and will not be required to take any steps to safeguard the confidentiality of any information that you provide, other than as specified in the Privacy Statement (defined below).

- You expressly authorize Zuora and all other persons or entities involved in the operation of the Zuora Community the right to transmit, monitor, retrieve, store, and use your information, including Submissions, in connection with the operation of the Zuora Community and in the provision of services to you.
- In the event that Zuora makes available content, software, APIs, or product documentation in connection with the Zuora Community ("Content"), you may use such Content solely in connection with, and pursuant to, your authorized use of Zuora's products and services.
